**PROGRAM STAFFING UPDATES:** The Benodjenh Center currently has 8 openings. There are 3 part time positions vacant, they are: 2 EHS Classroom/Bus Aides and 1 Bus Driver. There are 5 full time positions vacant, they are: the Bookkeeper/Assistant Director, the HS Education & Family Services Coordinator, 1 EHS Classroom/Bus Aide, 1 Early Head Start Home Visitor, and 1 HS/GSRP Assistant Teacher.

An interview was conducted for our vacant HS Classroom/Bus Aide Position on 5/5/21 and a recommendation of hire was completed on 5/5/21. HR said that this applicant never showed for the required tests/screens, so at this time the candidate is no longer going to be considered for this position however, they will be eligible to apply again in 90 days.

On 6/28/2021, Head Start Assistant Teacher, Alejandra Castellanos resigned from her position. Her last day is on Monday, July 12, 2021.

On 6/28/2021, Early Head Start Education & Family Services Coordinator, Leona Burfield resigned from her position. Her last day is on Monday, July 12, 2021.

Now that we are partnering with the Father Fred Organization, we are only providing and sending home breakfast, lunch, and snack for each child every other Wednesday during the afternoon bus drop off (6/25, 6/16, & 6/30). The Father Fred Organization is delivering food to us and we are distributing it to our families on the other Wednesdays each month (6/9 & 6/23). The Father Fred food Project provides food for the whole family (non-perishables, fresh produce including fruits and vegetables, eggs, cheeses, bread, and frozen foods. Each family also gets a tube of toothpaste, soap, and toilet paper.
